SUBSCRIBE NEW SHARES IN INDUS COFFEE PRIVATE LIMITED

The Board of Directors of Food Empire Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) wishes to announce that the Company’s wholly-owned subsidiary, EpiQ Food Services Pte Ltd (“**EpiQ**”), has subscribed for 499,076 new shares at par value of Rs100.00 each and share premium of Rs30.00 each in the share capital of Indus Coffee Private Limited (“**Indus Coffee**”), a subsidiary of the Company and of EpiQ, for a total cash consideration of Rs64,879,880.00 (equivalent to USD999,998.15).

Following completion of the new share subscription, the total issued and paid-up share capital (excluding share premium) of Indus Coffee has increased from Rs248,252,200.00 (equivalent to USD4,320,782.75) to Rs298,159,800.00 (equivalent to USD5,090,012.10) comprising 2,981,598 shares at par value of Rs100.00 each, of which:

- (i) 2,981,597 shares at par value of Rs100.00 each are held by EpiQ; and
- (ii) the remaining 1 share at par value of Rs100.00 is held by Future Investment Holdings Pte Ltd, a wholly-owned subsidiary of the Company.

The above transaction was funded through internal resources and is not expected to have any material impact on the consolidated net tangible assets and earnings per share of the Group for the current financial year.

None of the Directors or controlling shareholders of the Company has any interest, direct or indirect, in the above transaction.
